Subject: Joint action for simultaneous sealing/demolition of premises and removal/disconnection of electricity connections pursuant to the Order dated 12.06.2026 of the Hon'ble Electricity Ombudsman in Appeal No. 08/2026 (Smt. Narayani Devi Vs. BSES Yamuna Power Limited).

Dear Sir,

Kindly refer to the Hon'ble Electricity Ombudsman, vide Order dated 12.06.2026 passed in Appeal No. 08/2026 titled "Smt. Narayani Devi Vs. BSES Yamuna Power Limited, while upholding the order dated 04.02.2026 passed by CGRF-BYPL in Complaint No. 444/2025. The copy of the Order dated 12.06.2026 is enclosed herewith as **Annexure A**. In this regard, it is brought to your kind notice that the Hon'ble Electricity Ombudsman, vide Order dated 12.06.2026 has passed the directions whose relevant part is mentioned below;

"(ii) All the 13 connections (CA Nos. 101099347, 101146037, 151304503, 152096716, 101145932, 151349748, 152134077, 152134078, 151585182, 101102451, 122238008, 152878130, 152878128) mentioned in appeal need review by the Respondent in view of the safety of lives and properties urgently.

(iii) Action taken report be shared to this office within 30 days."

In view of the above, and in continuation of the joint exercise already undertaken between BYPL, DTL and MCD for identification of unsafe premises under the said EHV line, it is requested that DTL may kindly expedite coordination with MCD for booking/initiating action (sealing and/or demolition, as the case may be) in respect of the premises corresponding to the 13 CA Nos. mentioned in the Ombudsman's Order (reproduced in para 2 above). The list comprising address against each CA No. is enclosed herewith as **Annexure B**.

Once these premises were booked by MCD for sealing or demolition, DTL may kindly intimate this office of the scheduled date sufficiently in advance, so that officials of BYPL, DTL and MCD may jointly visit the premises and simultaneously carry out sealing/demolition of the premises by MCD, and disconnection and removal of the corresponding electricity connection (CA No., as applicable) by BYPL.
